## Minutes – June 17, 2020 NTxPCC Board of Directors Meeting via Interactive Zoom Session

The scheduled meeting was called to order by President Dillon at 7:00 PM

The 2020 Year to Date Financials were presented by President Dillon for the sake of information. The report is included as an addendum to these minutes. As the report was for information purposes there was minimal comment.

Cancellation of the 2020 Symposium was reviewed by President Dillon. Although uncertainty prevails regarding 2021 the McKesson venue is currently available during the second half of April 2021. Because of the cancellation refunds were made to vendors. Texas Health Harris elected to leave its support intact as a draw against future symposium expenses.

President Dillon presented plans and schedule for three Interactive ZOOM sessions to be held in the near future. Dates, speakers, and topics are:

Cost for a Zoom license is approximately \$125. Honorariums for speakers is \$1,300. In lieu of asking for sponsorship it was proposed that the expenses be covered by NTxPCC. Mr. Blattner moved to this effect, seconded by Ms. Strange. The motion passed by acclamation with no dissention.

Mr. Nagy proposed that previous supporters of NTxPCC receive gratis recognition in advertisements for the Interactive Zoom sessions. After some discussion Mr. Nagy moved to that effect with a second by Mr. Reynolds. The motion passed by acclamation and no dissention.

Mr. Blattner reviewed September proclamations activity that is quite positive with participation by 6 counties and 4 cities. A more detailed schedule as of this meeting is an addendum to these minutes.

Mr. Brown reviewed a potential schedule of various community events asking for NTxPCC support. In light of the current Covid 19 pandemic all future events through September 2020 are cancelled. The Pate Swap meet and car show, scheduled for October 3, 2020, is still uncertain.

There being no further topics put forward the meeting was adjourned at 7:45 pm by general consensus.
